**Abstract.** *For the rest of the paper, please use Times Roman (Times New Roman) 12.* This document explains and demonstrates how to prepare your camera-ready manuscript for the proceedings of the 17<sup>th</sup> *European Conference on Fracture*. The best is to read these instructions and follow the outline of this text. The text area for your manuscript must be 17 cm wide and 25 cm high (6.7 and 9.8 inches, resp.). Do not place any text outside this area (please do not change the document setting from A4 to letter). Please keep this in mind when designing your figures and tables etc.

### Introduction

All manuscripts must be in English. Please *keep a copy* of your manuscript in your office (just in case anything gets lost during submitting). When receiving the manuscript, we assume that the corresponding author grants us the copyright to use the manuscript for the proceedings in question. Should authors use tables or figures from other Publications, they must ask the corresponding publishers to grant them the right to publish this material in their paper.

Use *italic* for emphasizing a word or phrase. Do not use boldface typing or capital letters except for section headings (cf. remarks on section headings, below).

**Extent:** invited lectures according to author's consideration, all other papers 8 pages.

### Organization of the Text

**MSWord document styles.** This template contents 11 styles marked by self-explaining names, prepared for an easy formatting the text: *ECF17Title*, *ECF17Author(s)*, *ECF17Address*, *ECF17Keywords*, *ECF17Abstract*, *ECF17Section Heading* *ECF17Equation*,, *ECF17Paragraph (1<sup>st</sup>)*, *ECF17Paragraph (others)*, *ECF17Footnote*, *ECF17Reference*. Please do not change their settings and use these styles (if it is possible).

**Section Headings.** The section headings are in boldface capital and lowercase letters. *Second level* headings are typed as part of the succeeding paragraph (like the subsection heading of this paragraph).

**Page Numbers.** Do *not* set page numbers.

**Tables.** Tables (refer with: Table 1, Table 2, ...) should be presented as part of the text, but in such a way as to avoid confusion with the text. A descriptive title should be placed above each table. The caption should be self-contained and placed *below or beside* the table. Units in tables should be given in square brackets [meV].

**Figures.** Figures (refer with: Fig. 1, Fig. 2, ...) also should be presented as part of the text, leaving enough space so that the caption will not be confused with the text. The caption should be

self-contained and placed *below or beside* the figure. Generally, only original drawings or photographic reproductions are acceptable. Utmost care must be taken to *insert the figures in correct alignment with the text*. Half-tone or color pictures can be used. Please include your figures as graphic images in the electronic version. For best quality the pictures should have a resolution of 300 dpi (dots per inch).

**Equations.** Equations (refer with: Eq. 1, Eq. 2, ...) should be indented 5 mm (0.2"). There should be one line of space above the equation and one line of space below it before the text continues. The equations have to be numbered sequentially, and the number put in parentheses at the right-hand edge of the text (use *tab* key). Equations should be punctuated as if they were an ordinary part of the text. Punctuation appears after the equation but before the equation number, e.g.

$$c^2 = a^2 + b^2. \tag{1}$$

## References

References are cited in the text just by square brackets [1]. Two or more references at a time may be put in one set of brackets [3,4]. The references are to be numbered in the order in which they are cited in the text and are to be listed at the end of the contribution under a heading *References*, see our example below.

## Summary

The contribution should be prepared in the electronic form as a standard document format DOC, and a suitable text editor (as MS Word) should be used. The manuscript is to be submitted by using the ECF17, registration form (web <http://ecf17.fme.vutbr.cz>). We strongly recommend to convert the electronic version into the PDF format and to send *both DOC and PDF versions* to the Organizing Committee. If you cannot prepare the PDF version, a print-out of the valid electronic version should be made and sent to the Organizing Committee by surface mail. If you follow the foregoing, your paper will conform to the requirements of the publisher and facilitate a problem-free publication process.
